The purpose of this bridge letter is to address the period between the end of the examination period (**31 March 2026**) and the issuance of the final SOC 2 Type II and SOC 3 reports, which are currently being finalized by our independent auditor, **Securance**, during April 2026.

During the month of April 2026, Securance has been engaged in completing standard post-fieldwork procedures. These activities include, but are not limited to:

- Internal quality assurance and technical reviews
- Report drafting, editing, and redaction processes
- Finalization of the SOC 2 Type II and SOC 3 reports

No additional control testing covering periods after 31 March 2026 is performed as part of the SOC 2 Type II examination.

The final SOC 2 Type II and SOC 3 reports are expected to be issued following completion of Securance's procedures in April 2026.
